## Here's what else you need to know:

- There are no plan design changes or new contracts for you to sign.
- There are no additional fees for your group to pay.
- For plans that cover diagnostic and preventive services at less than 100%, the platform will calculate the member's coinsurance at the time of service. It will clearly display how much an employee owes, if any.
- Ineligible members and members who choose not to use their benefits may choose to pay \$35 out of pocket for a virtual dental assessment. This option may be useful for members whose plans don't cover virtual dentistry.<sup>2</sup>
- The platform is HIPAA-compliant, and all health information stored and sent through the platform is encrypted, safe and secure.
