## Earn more with our updated rewards program<sup>1</sup>

Enroll in Delta Dental's Small Business Producer Rewards Program at ddsbrewards.com, and you could earn additional compensation for selling and retaining eligible groups of  $2-99.^{2}$ 



#### How does it work?



To qualify, you need to retain 85% of your book of business. Our lowest threshold is \$50,000.

- New to selling Delta Dental? Your new sales alone qualify.
- Already enrolled? Be sure to log in to ddsbrewards.com to qualify.

New sales bonuses are based on the number of new groups or the total new annualized premium received for effective dates in the current calendar year. As you sell and retain your existing business with Delta Dental, your rewards grow. And this rewards program is on top of your existing standard small business commission.

Your retention bonus will be tied to your sales tier. For example, if you sell 15 new groups and retain 90% of your existing book of business, you'll qualify for a 1.5% retention bonus. But if you sell 15 new groups and retain 95% or more, you'll qualify for 2% bonus.

#### What else should I know?

- Only fully insured small commercial businesses (2-99 enrolled employees) qualify as eligible.<sup>4</sup>
- Rewards will be calculated and paid after December 31 of the current year.
