## Dental benefit overview

Members have a calendar year maximum for covered supplemental dental services and each service has a specific limit (e.g., maximum allowance, number of procedures, and/or frequency of services). In Hawaii, both plans cover preventive dental services, which do not count towards the calendar year maximum. See the detailed plan summary for more information.

The annual calendar maximums vary by plan and are outlined below in the plan summaries for easy reference. The costs of all covered supplemental dental services cannot exceed the plan benefit maximum in a calendar year (excluding preventive services where preventive services don't apply to annual maximums).
